ARTICLE I – NAME

The name of this corporation is INTERNATIONAL ORNAMENTAL, INC. (the “Corporation”).

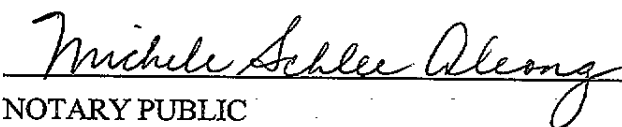

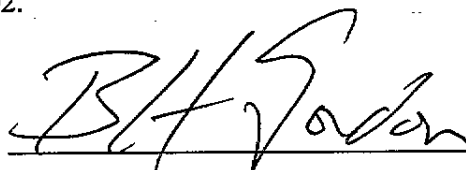
