BY THESE ARTICLES OF INCORPORATION the incorporator form corporation for profit under Florida law.

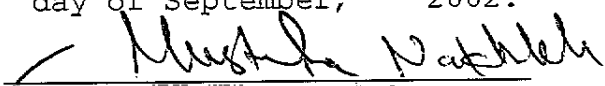
1. NAME. The name of this corporation is SAMER'S CORPORATION.

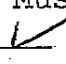

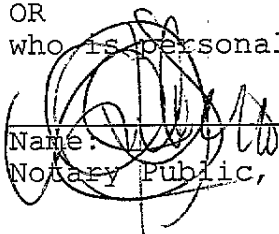
