THIRD: Dissolution was authorized on September 29, 2009.

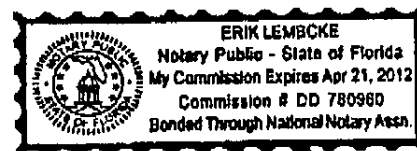
