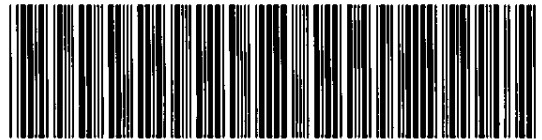

OPALOCKA, FL 33054

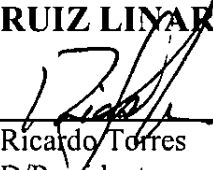
