

# ARTICLES OF INCORPORATION FLORIDA FOR-PROFIT CORPORATION

### ARTICLE I

<u>Name</u>

The name of the Florida For-Profit Corporation is: <u>LIGHTHOUSE ANESTHESIA SERVICES, INC.</u> (hereafter "Company").
