
ARTICLE IX AMENDMENT OF ARTICLES

ARTICLE X INDEMNIFICATION



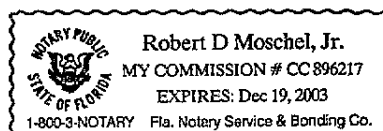
