

**ARTICLES OF INCORPORATION
OF
PAUL F. ANGUEIRA, P.A.**

The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, an attorney-at-law, and a member of the Florida Bar, hereby forms a professional association for profit pursuant to the provisions of the Professional Services Corporation Act and other laws of the State of Florida.

ARTICLE ONE

Name

The name of the corporation is **PAUL F. ANGUEIRA, P.A.** The address of the principal office of this corporation shall be 2200 WEST COMMERCIAL BOULEVARD, SUITE 102, FORT LAUDERDALE, FLORIDA 33309 and the mailing address shall be the same.

ARTICLE TWO

Duration

The term of existence of the corporation is perpetual, commencing September 23, 2002.

ARTICLE THREE

Purpose

- B. To invest and reinvest the funds of this corporation in real estate, mortgages, stocks, bonds of any other type of investments within the meaning of Chapter 621.08, Florida Statutes, and to acquire and own real and personal property necessary for the rendering of professional services in the practice of law.
- C. To do each and every thing necessary and proper for the accomplishment or furtherance of any purposes or objects of this corporation enumerated in these Articles of Incorporation, or any amendment thereof, necessary or incidental to the protection and benefit of this corporation; and, in general, either alone or in association with other corporations, firms or individuals, to carry on any lawful pursuits necessary or incidental to the accomplishment or furtherance of such purposes or objects of this corporation.
- D. To conduct and transact any business lawfully authorized and not prohibited by Chapter 621, Florida Statutes, as the same may be amended from time to time.

ARTICLE FOUR

Capital Stock

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having \$1.00 par value per share.

The street address of the initial registered office of the corporation shall and the name of the initial registered agent of the corporation at that address is PAUL F. ANGUEIRA.


