**ARTICLES OF INCORPORATION  
OF  
CATHEDRAL DOORS, INC.**

THE UNDERSIGNED, who desires to form a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the Corporation shall be **CATHEDRAL DOORS, INC.** ("Corporation")

**ARTICLE II - PURPOSES**

The general purposes for which this corporation is organized are:

- (1) To transact any lawful business or businesses for which corporations may be incorporated under the Florida General Corporation Act; and,
- (2) To do such other things as are incidental to the foregoing or necessary, implied, helpful, or desirable in order to accomplish the foregoing.

**ARTICLE III - DURATION**

Corporate existence of the Corporation will begin on October 1, 2002, and is perpetual.

**ARTICLE VI - CAPITAL STOCK**

The number of shares of capital stock that the Corporation is authorized to issue is 1000 shares, all of which shall be voting common shares with par value of \$1.00 per share.

**ARTICLE V - REGISTERED OFFICE AND AGENT**



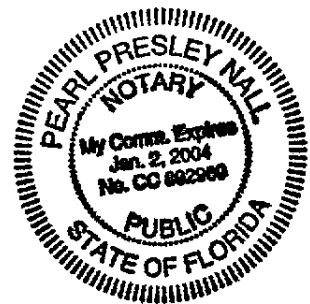

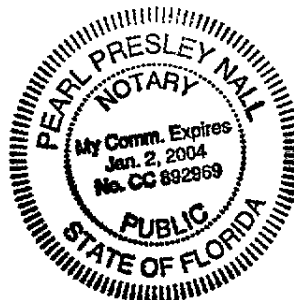
