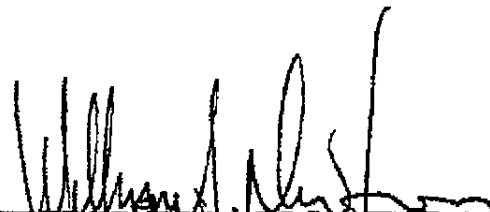
Pursuant to Section 607.1403, Florida Statutes, the undersigned hereby execute these Articles of Dissolution and provide as follows: _____

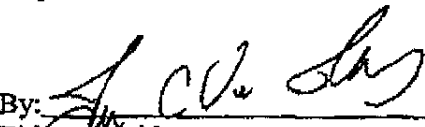

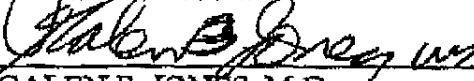
