I. the undersigned natural person of the age of eighteen (18) years or more, acting as incorporator of a profit corporation in compliance with Chapter 621, Florida Statutes, do hereby adopt the following Articles of Incorporation for such corporation:

I.

The period of this duration is perpetual.

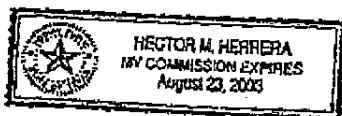


