## **Articles of Incorporation**

of

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

- Article 1: Name. The name of the Corporation is: SEAHORSE ON THE BEACH, INC.
- Article 2: Duration. The duration of the Corporation is perpetual.
