ARTICLE I - NAME

The name of this corporation is CRESTHAVEN COIN LAUNDRY, INC., with its principal office and address being located within the Shoppes at Cresthaven, 2601 S. Military Trail, West Palm Beach, Florida 33415.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation by the Department of State.

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE IV - CAPITAL STOCK

ARTICLE IX - INDEMNIFICATION

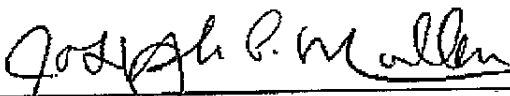
The corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.

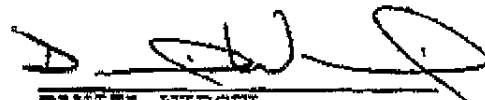
