Gentlemen:

I am writing this letter to you with regard to an apparant problem with the 2003 Uniform Business Report for the above referenced corporation of which I am the sole stockholder.

I recently received a notice from your offices indicating that I have not filed said report for the current year, and also indicating that the corporation would be administratively dissolved shortly; also that if the report was filed between now and that date a resulting late filing penalty would be assessed. Please understand that this current notice is the first notice that I have received all year regarding this; upon receipt of such notice I consulted with a professional familiar with such matters and was subsequently to write this letter to you. I was further advised to enclose a completed Uniform Business Report for the current year, together with a check in the amount of \$158.75 to cover the normal filing fee and also the additional charge for a certified copy, which I have done.

I am at a loss to understand why I did not receive the original report which I was advised should have been received during the early part of the calendar year; it appears as though you have the correct address of the business in your records or I would not have received your current notice. There have been no problems with U.S. Postal Service regarding the delivery of my mail, at least that I'm aware of.

Therefore, I ask that you accept the enclosed report as originally filed and waive the late filing penalty; my business was incorporated during 2002 and 2003 would have been the first year for which a report would have been required.
