ARTICLES

WE, THE UNDERSIGNED, ASSOCIATE OURSELVES TO BECOME A  
FLORIDA CORPORATION.

#### ARTICLE XI

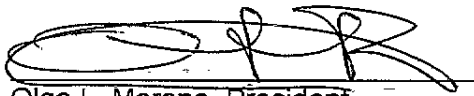
