**ARTICLES OF INCORPORATION
OF
BEST INSURANCE OF FLORIDA, INC.**

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is BEST INSURANCE OF FLORIDA, INC., and the principal address and principal place of business is 4556 SOUTH MANHATTEN AVENUE, SUITE J, TAMPA, FLORIDA 33611.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is c/o O'CONNOR & ASSOCIATES, 2240 Belleair Road, Suite 160, in the City of Clearwater, County of Pinellas, Florida 33764. The name of its registered agent at such address is PATRICK M. O'CONNOR, ESQUIRE.
