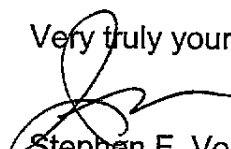

The name of this corporation is WYER ENTERPRISES, INC.

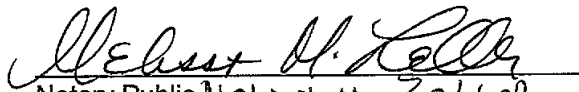

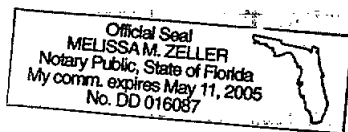
