ARTICLES OF INCORPORATION OF

E. LOPEZ CORP.

in compliance with the Florida Business Corporation Act

ARTICLE I - NAME OF CORPORATION:

The name of the corporation shall be E. Lopez Corp.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS:

The principal place of business and mailing address of the corporation is 9940 Marlin Road Miami, Fl. 33157.

ARTICLE III - PURPOSES:

The name and street address of the incorporator is Emilio Lopez, 9940 Marlin Road Miami, Fl. 33157.


ARTICLE VII - EFFECTIVE DATE:
