ARTICLES OF INCORPORATION
OF
DADE-1995, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, docs hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is DADE-1995, INC.

ARTICLE II

The existence of this corporation shall be perpetual unless dissolved according to Florida law. In the event of dissolution of this corporation, all remaining assets of the corporation shall be transferred and delivered according to Florida law.

ARTICLE III

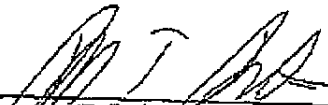
