***DURATION:***

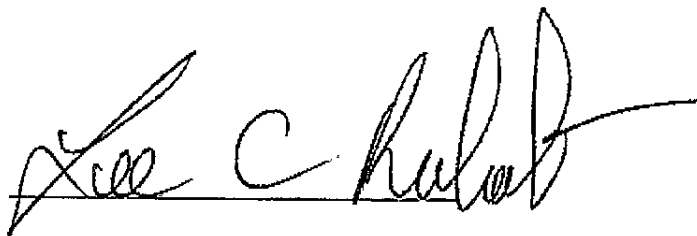

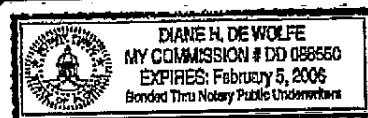

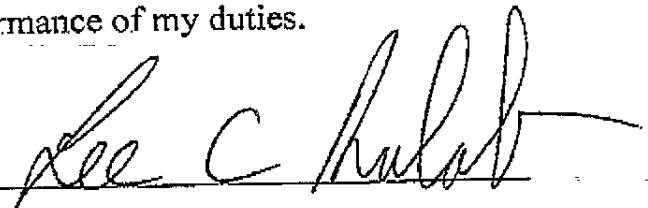
