## ARTICLES OF INCORPORATION

OF

#### NaturalVets, Inc.

The undersigned, acting as an Incorporator of a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### ARTICLE I - Name

The name of the corporation is: NaturalVets, Inc.

# **ARTICLE II - Principal Office and Mailing Address**
