**ARTICLES OF INCORPORATION  
OF  
LAWPROSEARCH, INC.**

In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

**ARTICLE 1  
NAME OF CORPORATION**

The name of the Corporation shall be LAWPROSEARCH, INC.

**ARTICLE 2  
DURATION OF CORPORATE EXISTENCE**

The duration of the Corporation shall be perpetual.

**ARTICLE 3  
PURPOSE OF CORPORATION**

The Corporation is formed for the purpose of operating and transacting any and all lawful business.

**ARTICLE 4
