ARTICLES OF INCORPORATION OF JO-KO, INC.

<u>ARTICLE I</u>

The name of the corporation shall be JO-KO, INC. and its mailing address shall be 20100 West Country Club Dr. #1606, Aventura, FL 33180.

This corporation shall have perpetual existence commencing upon the filing date of these Articles of Incorporation with the Secretary of State of Florida.
