ARTICLES OF INCORPORATION OF EMTK IMAGEN, INC.

The undersigned incorporators for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

<u>ARTICLE I - NAME</u>

The name of this corporation is EMTK Imagen, Inc.(hereinafter referred to as the "Corporation").
