ARTICLES OF INCORPORATION

OF

MARY S. LILLY, O.D. & ASSOCIATES, P.A.

The undersigned, for the purpose of forming a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, does hereby adopt the following Articles of Incorporation.

<u> Article I - Name</u>

The name of the Corporation shall be MARY S. LILLY, O.D. & ASSOCIATES, P.A. The principal place of business of this Corporation shall be 1208 E. Brandon Blvd., Brandon, Florida or such other place as may be designated by the Board of Directors.

Article II - Duration

This Corporation shall have perpetual existence. The date and time of the commencement of corporate existence shall be upon filing.

Article III - Purpose

The Corporation is organized as a Professional Service Corporation as permitted under the Florida Statutes and the Corporation will be engaged in the practice of optometry within the State of Florida, and to take all actions necessary or proper in connection with that practice.

Article IV - Professional Services

The professional services of the Corporation shall be rendered only through its Officers, employees, and agents who are duly licensed or otherwise legally authorized to practice optometry within the State of Florida. Professional services shall be rendered in each case by the Officer, employee, or agent designated solely by this Corporation, acting through its duly elected Officers. This provision shall not be applicable to the extent it is in conflict with the law or the professional rules of optometry practices.

Article V - Capital Stock

The total authorized capital stock of this Corporation shall consist of Ten Thousand shares of common stock having a par value of One Dollar (\$1.00) each, amounting in the aggregate to Seven Thousand Five Hundred Dollars (\$10,000.00). All stock issued shall be fully paid and non-assessable.

Article VI - Initial Registered Office and Agent

The street address of the initial registered office of this Corporation is c/o Vision Works, 1208 E. Brandon Blvd., Brandon, Florida 33511 and the name of the initial Registered Agent of this Corporation at that address is MARY S. LILLY.

Article VII - Initial Board of Directors

This Corporation shall have One Director initially. The number of Directors may be either increased or diminished from time to time by the By-Laws, but shall never be less than one. The name and address of the initial Director of this Corporation is:
