ARTICLES OF INCORPORATION
OF
MOMENTO MIAMI PRODUCTIONS, INC.

The undersigned incorporator of this Corporation under Chapter 607, Florida Statutes, as amended, adopts the following Articles of Incorporation.

ARTICLE I

The name of this Corporation is: MOMENTO MIAMI PRODUCTIONS, INC.

ARTICLE II

The principal place of business of this Corporation shall be 2413 Galiano Street, Coral Gables, Florida 33134.

ARTICLE III

The Corporation shall have perpetual existence.

ARTICLE IV

The general purpose for which the Corporation is organized is the following: to engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act, and to do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE V

The maximum number of shares which this corporation is authorized to have outstanding at any time is One Thousand (1,000) shares of common stock having a par value of One and 00/100 Dollars (\$1.00) per share. ARTICLE VI

The initial registered office of this Corporation shall be 150 Alhambra Circle, Suite 1270, Coral Gables, Florida 33134, and the initial registered agent of this Corporation at such office shall be Lawrence S. Evans, who, by signing these Articles of Incorporation, accepts the designation and agrees to comply with the provisions of Section 48.091 Florida Statutes as amended from time to time with respect to keeping an office open for service of process.

ARTICLE VII

The initial Board of Directors shall consist of three (3) members. The number of directors may be increased or decreased from time to time by vote of the shareholders.
