
ARTICLE XI - MEETINGS

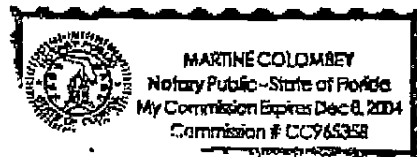
