ARTICLES OF INCORPORATION

OF

BLUE MOON THAI & JAPANESE, INC.

The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Blue Moon Thai & Japanese, Inc.

ARTICLE II - COMMENCEMENT & DURATION

The corporation shall commence its existence on September 26, 2002 and shall exist perpetually unless sooner dissolved according to law.

ARTICLE III - ADDRESS

ARTICLE IV - STATED CAPITAL

The corporation is authorized to issue the following capital stock:

The corporation shall have one director initially. The number of directors may be increased or decreased from time to time thereafter according to the bylaws of the corporation but shall never be less than one. 
ARTICLE VIII - SHAREHOLDER PROPERTY

ARTICLE IX - AMENDMENTS TO ARTICLES


The Directors shall have the power to amend or repeal these Articles of Incorporation with not less than a two-thirds vote of the common stock.
