The undersigned subscribers to these Articles of Incorporation are natural persons competent to contract, and hereby form a corporation for profit under the laws of the State of Florida.

**Article I**  
**NAME**

The name of the corporation is **A PLUS OFFICE SUPPLY & EQUIPMENT, INC.**

**Article II**  
**NATURE OF BUSINESS**

The general purposes for which the corporation is organized are:

(A) To buy and sell all office supplies and equipment of all nature; sell and service office equipment..

(B) To transact any other lawful business for which corporations may be incorporated under the Florida General Corporation Act or engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

(C) To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

**Article III**  
**CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is **500 (FIVE HUNDRED) shares of common stock**, each share having a par value of **FIVE DOLLARS (\$5.00)**.

**Article IV**  
**SUBCHAPTER S**

This corporation is authorized to issue only one class of stock, and all issued stock shall be held of record by not more than ten persons. Stock will be issued and transferred only to (1) natural persons, (2) estates, or (3) a trust as described in title 26 United States Code Section 1371 defining a qualified "small business corporation". In addition, no stock shall be issued or

transferred to a nonresident alien. The intent is to have a Subchapter S Corporation.

Article V  
**INITIAL CAPITAL**

The minimum amount of capital with which this corporation shall begin business is **TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500.00).**

Article VI  
**INITIAL ADDRESS AND AGENT**

The registered agent for A PLUS OFFICE SUPPLY & EQUIPMENT, INC. is:

**TERM OF EXISTENCE**

This corporation shall have perpetual existence.

Article VIII  
**DIRECTORS**

The corporation shall have TWO directors initially. The number of directors may be increased or diminished from time to time by By-Laws adopted by the stockholders but shall never be less than one.

These Articles of Incorporation shall be on a calendar year basis and shall be effective as of September 20th, 2002.

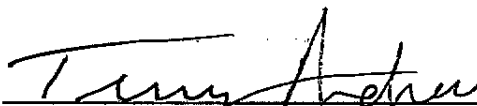
