Attached you can find the emails sent to you and your answer, based on them I believed my UBR was OK.

I sent my UBR in april 6<sup>th</sup>, 2003, and the checkbank for US\$150, which were received by you. I forgot to write the EIN, so I sent an email to you on april, 08 2003, asking how I could let you know the EIN, your answer was by email, after that you updated the information and my EIN is in your Record right now.

On august, 28 2003, I asked you again if I had to pay and resend my UBR, your answer was "The 2003 UBR report has been filed for the listed corporation" (see attached copy of email), I understood the UBR was ok.

Now my Corp is under dissolution. I'm sorry if I misunderstood, english is not my mother language, and this is the first time I file an UBR.
