My accountant has just advised me that the Annual Uniform Business Report has not been submitted. Neither package nor information was received and the principal address information has not changed.


As this is the first year I am filing this report, I would like to request your acceptance of the completed and attached form and the payment enclosed of \$150.00 for document number P02000104695.
