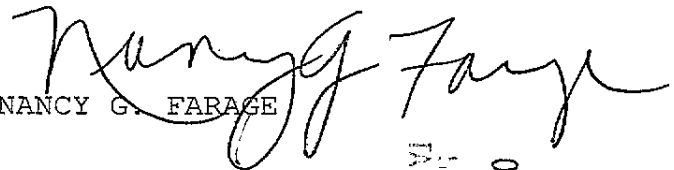

##### BY-LAWS

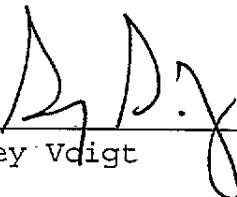
