The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I - NAME

The name of the corporation shall be FIL-AM NEWS OF FLORIDA, INC.

ARTICLE II - PURPOSES

The purposes for which the corporation is organized is to publish a community newspaper or to transact any or all lawful business for which corporations may be organized under the Florida Business Corporation Act.

ARTICLE III - AUTHORIZED SHARES
