**Articles of Incorporation
of
West Coast Eye Care, Inc.
A Florida Corporation**

The undersigned incorporator adopts the following Articles of Incorporation for purposes of forming a corporation under the Florida Business Corporation Act:

1. Name

The name of the Corporation is West Coast Eye Care, Inc. The Corporation's principal office (and mailing address) is located at 15640 New Hampshire Court, Fort Myers, Florida 33908 in Lee County, Florida.

2. Capital Structure

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any time is ten thousand (10,000) shares of common stock having one dollar (\$1.00) par value per share.

3. Term of Existence

The Corporation's existence shall commence on the date of filing these Articles of Incorporation in the office of the Florida Secretary of State, and the Corporation shall have perpetual existence thereafter.

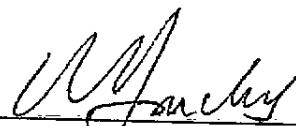
4. Incorporator
