ARTICLES OF INCORPORATION
STETSON OFFSHORE GRAPHICS, INC.

The undersigned subscribes to these Articles of Incorporation, each a natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I: NAME

The name of the corporation is: STETSON OFFSHORE GRAPHICS, INC.

ARTICLE II: NATURE OF BUSINESS

The general purposes for which the corporation is initially organized are the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida.

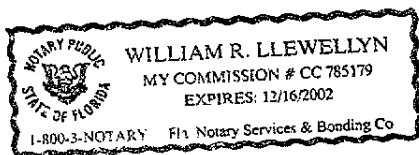
