ARTICLES OF INCORPORATION OF SECRETARY OF STATE NIGHT OWL INVESTIGATIONS, INC. SECRETARY OF STATE PLORIDA

The undersigned, for purposes of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

ARTICLE ONE: NAME

The name of the corporation is NIGHT OWL INVESTIGATIONS, INC.

ARTICLE TWO: CORPORATE DURATION

The duration of the corporation is perpetual and shall commence upon filling.

ARTICLE THREE: PURPOSE OR PURPOSE

The general purpose for which the corporation is organized are:

- Engage in the business of investigations, service of process, including subpoenas, summons, and other investigating techniques.
- 2.
