ARTICLES OF INCORPORATION

OF

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is David's Catering and Banquet Center, Inc.

ARTICLE II

The street address of the principal office of the Corporation is 2500 N. Military Trail, Suite 480, Boca Raton, FL 33431.

ARTICLE III

The maximum number of shares the Corporation is authorized to have outstanding at any one time is 7500 shares, all of which shall be Common Shares having a par value of 10 cents per share.




