

The undersigned hereby makes and subscribes these Articles of Incorporation intending to form a corporation under the provisions of Chapter 607, Florida Statutes.

ARTICLE I - NAME

The name of this corporation is FULLER BUSINESS CONSULTING, INC.

ARTICLE II – PURPOSE

The corporation may engage in any activity or business permitted under the laws of the United States or of the State of Florida. While engaging in such activities or businesses, it may exercise all of the powers and privileges conferred by Chapter 607, Florida Statutes, as presently in effect and as amended from time to time in the future.

ARTICLE III – CAPITAL STOCK

The corporation is authorized to issue one thousand (1,000) shares of common stock, each share having a par value of \$1.00.

ARTICLE IV – DURATION

The corporation shall have perpetual existence, beginning in accord with law.

ARTICLE V – INITIAL REGISTERED OFFICE AND AGENT
