CERTIFICATE OF INCORPORATION

OF

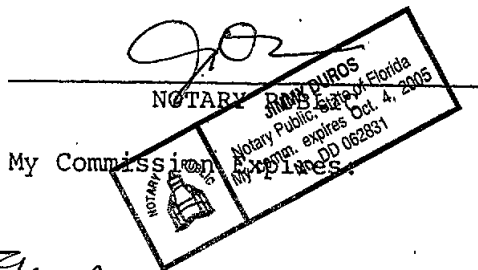
