

The undersigned, desiring to incorporate under the laws of the State of Florida, hereby submits the following:

ARTICLE I

The name of the corporation is 441 BRIDAL GOWN & FLOWER CENTER, INC..

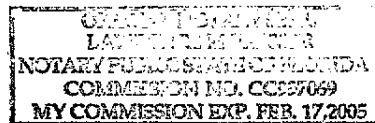


