ARTICLES OF INCORPORATION

EXPRESS SHIPPING & TOWING, INC. SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, desiring to form a corporation under and by virtue of the laws of the State of Florida providing for the formation, liability, rights, privileges and immunities of a corporation for profit, states as follows:

ARTICLE I Name and Address of Corporation

The name of this corporation shall be EXPRESS SHIPPING & TOWING, INC., and the principal business and mailing address is 251 East Taft Vineland Rd., Taft, Florida 32824.

ARTICLE II Objects and Purposes of Corporation

The objects and purposes of the corporation and the general nature of the business or businesses to be transacted shall be:

- To engage in any lawful businesses permitted or allowed under the Florida General Corporation Act.
- To make and enter into all contracts necessary and proper for the conduct of its business or businesses.
- To borrow money from any person, firm, or corporation; to issue bonds, debentures, or obligations of this corporation from time to time for any of the objects or purposes of the corporation; and to secure same by mortgage, pledge or by any other lawful means.
- To have offices, conduct its business and promote its objects within or without the State of Florida, in other states, the District of Columbia, the territories and possessions of the United States, and in foreign countries without restriction as to place or amount.

6. In general, this corporation shall have and exercise all the powers conferred by the laws of the State of Florida upon corporations for profit. It is hereby expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner such general powers.

ARTICLE IX

Identity of Incorporator; Pre-emptive Rights

The name and address of the incorporator is Alan D. Potter, 251 East Taft Vineland Rd., Taft, FL 32824.

Every shareholder of the corporation, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done

without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE X Annual Meeting of Shareholders

- 1. The annual meeting of the shareholders shall be held on the first Monday of January of each year, or at such other time as may be fixed by the By-Laws, at which time the Board of Directors shall be elected and such other business as may properly come before the meeting may be considered and transacted.
