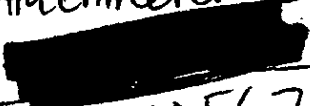

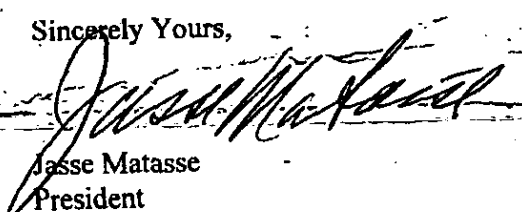
Re: Late Notice of 2003 Uniform Business Report
