## ARTICLES OF INCORPORATION OF ALLIED CREDIT RESTORATION SERVICES INC.

The undersigned, for the purpose of forming a corporation under the Florida Generation Act, do hereby adopt the following Articles of Incorporation

ARTICLE 1. Name: The name of the corporation is:

ALLIED CREDIT RESTORATION SERVICES INC.

ARTICLE 2. Duration: The duration of the corporation is perpetual

ARTICLE 3. Purpose: The general purpose for which this corporation is organized are the following.

- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way
