ARTICLE I
NAME

The name of the Corporation is CORPORACION ARISAR, Inc.

ARTICLE II

CAPITAL STOCK

The corporation is authorized to issue 60,000,000 shares of no par value common stock.

ARTICLE IV

The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE XI
