

**ARTICLE I. - NAME**

The name of this Corporation is TEXTILE STRATEGIES, INC.

**ARTICLE II. - DURATION**

This Corporation shall exist perpetually.

**ARTICLE III. - PURPOSE**




## ARTICLE VIII. - BY-LAWS



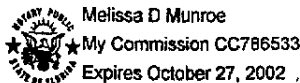
