

ARTICLE I – NAME

The name of this corporation is **J & J ENTERPRISES OF BRADFORD COUNTY, INC.**

The duration of this corporation shall commence upon acceptance and shall be perpetual.

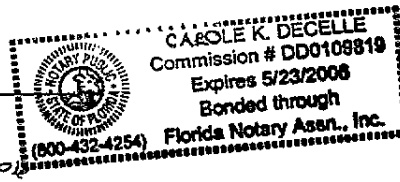
