**ARTICLES OF INCORPORATION
OF
CALVARY CARE LANDSCAPING, INC.
A FLORIDA CORPORATION FOR PROFIT**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I
Corporate Name**

The name of the corporation shall be Calvary Care Landscaping, Inc. ("Corporation").

**ARTICLE II
Date of Existence**

The existence of the Corporation shall begin on the date of incorporation.

**ARTICLE III
Principal Office and Mailing Address**

**ARTICLE IV
Capital Stock**

The maximum number of shares this corporation is authorized to issue is 110 shares, par value \$1.00 per share, all of which shall be common stocks. All holders of common shares shall be identical with each other in every respect and the holders of common shares shall be entitled to one vote for each share in all matters on which shareholders have the right to vote. The corporation elects to have preemptive rights.

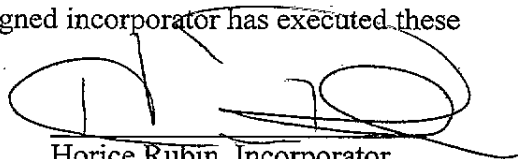
