**ARTICLES OF INCORPORATION
OF
FUTURE MOTORCYCLE ENTERTAINMENT, INC.**

The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation is Future Motorcycle Entertainment, Inc.

ARTICLE II

The corporation may engage in any and all activities and businesses permitted under the laws of the United States and of the State of Florida. The corporation shall have all of the power vested in a corporation organized under and existing by virtue of the laws of the United States of America and the State of Florida.

ARTICLE III

The maximum number of shares of stock, which the corporation is authorized to issue and have outstanding at any one time, is -1- share of common stock having a par value of \$10.00 per share.

ARTICLE IV

The existence of the corporation shall be perpetual. Corporate existence shall commence on the date these Articles are executed and acknowledged, except that if they are not filed by the Department of State of the State of Florida within five (5) days, exclusive of legal holidays, after they are executed and acknowledged, corporate existence shall commence upon filing by the Department of State.

ARTICLE V

The street address of the initial office of the corporation is 175 SW 20TH Way, Dania, Florida 33004. The street address of the initial registered office of this corporation is 1050 NE 215th Street, Miami, Florida 33179 and the name of the initial registered agent of this corporation at the address is Francine Hanna.

ARTICLE VI

The corporation shall have one director, initially. The number of directors may be increased or diminished from time to time pursuant to the Bylaws of the corporation, but shall not be less than one nor more than seven.

ARTICLE VII

A director shall not be prohibited or disqualified from voting on any issue, at any time, by reason of the fact that the issue under consideration may involve such director personally, directly or indirectly, or that it may involve any person, firm, corporation or other entity in which such a direct or indirect interest.

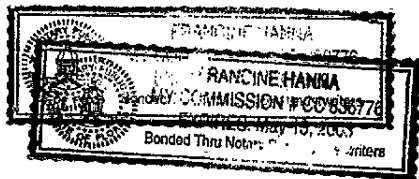
