The undersigned, for the purpose of forming a corporation for profit under the laws of the State of Florida, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

Name, Location and  
Mailing Address of Principal Office

The name of the corporation is FIRST COAST APPRAISAL SERVICES, INC. The principal office and mailing address of this corporation is 9404 Heckscher Drive, Jacksonville, Florida 32226.

**ARTICLE II**

Purpose

This corporation is organized for the purpose of transacting any and all business permitted under the laws of the United States and the State of Florida, specializing in appraisal of automobiles, property and casualty.

**ARTICLE III**

Capital Stock

The aggregate number of shares which the corporation is authorized to issue is five hundred (500). Such shares shall be of a single class, and shall have a par value of One Dollar (\$1.00) each. The shares of stock are to be issued as follows:

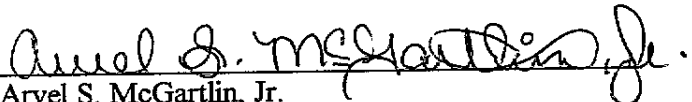
**ARTICLE IX**

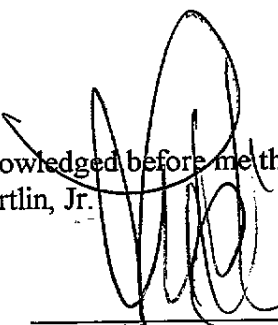
**ARTICLE X**

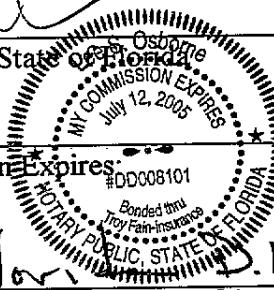
