**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
THE SOUTHEAST DIGEST, INC.**

The undersigned, being the President of the corporation, in accordance with Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, certifies that:

1. The name of the corporation is The Southeast Digest, Inc. (the "Corporation").
2. The Articles of Incorporation were originally filed on October 2, 2002 .

3. Article I of the Articles of Incorporation is hereby amended to change the name of the Corporation to Jo-In Associates, Inc., by striking out Article I in its entirety, and substituting in lieu thereof the new Article I as follows:


**"ARTICLE I
