**Articles of Incorporation of North Star Financial
Planning and Bookkeeping, Inc.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME. The name of the corporation shall be North Star Financial Planning and Bookkeeping, Inc.

ARTICLE II. PURPOSE. The purpose of the corporation shall be to provide financial planning and bookkeeping services and any and all business permitted under the laws of the State of Florida. The corporation may own real property and undertake any other lawful activity in the furtherance of the purposes set forth.
